HBAA Gearing up for Inaugural ABLE Conference Feb. 27-29 in Montgomery

he Home Builders Association of Alabama is preparing for the debut of Alabama's Better Living Expo (ABLE), a statewide green building and sustainability conference for industry professionals.

The 2012 ABLE will be held February 27-29 at the Montgomery Renaissance Hotel and Convention Center. It will take place in conjunction with the HBAA's Winter Meeting, giving members access to both ABLE and the HBAA's regular committee meetings for just \$79.

The HBAA has partnered with a variety of industry, environmental and regulatory groups to present ABLE. Alabama Power, Alagasco and the Alabama Department of Economic and Community Affairs have stepped up as ABLE's major sponsors. "This will be an industry show unlike any we've ever seen," said ABLE Coordinator Jason Reid. "This is not your typical consumer home show; this is geared toward residential and commercial building industry groups, architects, engineers, and others who have an interest in sustainable building."

The conference will include over 100 hours of seminars and continuing education in a variety of fields and more than 52,000 square feet of exhibit space displaying the latest sustainable products and services. The exhibit hall will feature four specially designed sponsored pavilions where attendees can hear a variety of seminars from nationally renowned speakers on topics ranging from updates on Alabama's energy code to geothermal heating and cooling to marketing homes to the next generation.



The ABLE conference will also give attendees the opportunity to earn Qualified Credentialed Inspector, lead paint renovator, Green EnergyKey and Certified Green Building Professional designations. Those classes will be offered throughout the conference for an additional fee (fees vary by class). On Tuesday evening, February 28, the

Canter, McQueen, Thomas Inducted into ABI Hall of Fame


he Alabama Building Industry Hall of Fame has three new inductees. C.G. "Bud" Canter, Jr., William N. "Billy" McQueen, Jr., and Robert W. "Bob" Thomas were inducted during the awards banquet at the 2011 HBAA Annual Convention in Huntsville.

Induction into the ABI Hall of Fame is the highest honor presented by the HBAA. Inductees are selected for their significant service to the residential housing industry in their communities and in the state of Alabama.

About the inductees:

Bud Canter, who currently serves as the president of C.G.Canter, Jr. & Associates, began building with his father in 1968. As an active member of both the Greater Birmingham Association of Home Builders and the Home Builders Association of Greater Calhoun County, he has held various leadership positions in both associations. He served three terms as President of the HBAGCC--in 1979, 1980 and 1993--and served as the 2011 President of the GBAHB.

At the state level, Canter has been actively involved with the HBAA for many years. He has served on the HBAA Nominating Committee since 2004 and has been a director of the Alabama Home Builders Foundation since 2006, serving as Foundation President in 2008. He was a member of the Hall of Fame selection committee in 2005 and 2006 and served as National Director. He has held every office at the HBAA, including serving as HBAA President in 2005. At the national level, Canter is a BUILD-PAC Gold Key member and has represented Alabama as a BUILD-PAC trustee since 2009. In 2007, he was named the HBAA Builder of the Year.





What You Need to Know about the New **Immigration Law**

ith the passage of the"Beason-Hammon Alabama Taxpayer and Citizen Protection Act", better known as the Alabama Immigration Law, there have been many questions as to how the law impacts employers. Attorney Mike Thompson of Lehr Middlebrooks & Vreeland conducted several seminars for HBAA members on the new immigration law, and has written an article explaining what employers need to know in order to comply. The following is an excerpt from the original article; to read the article in its entirety, visit www.HBAA.org.

The Basic Requirements Regarding Employment

The Alabama Immigration Law echoes federal law in many respects. At a basic level, the law makes it illegal for Alabama employers, public and private, to knowingly employ undocumented aliens. The law employs a rather cumbersome definition of knowingly but we anticipate that the law will evolve to include both actual knowledge and constructive knowledge to apply to the knowingly standard.

Actual knowledge will typically apply to circumstances where an employee admits his or her undocumented status whereas constructive knowledge will focus on the attendant circumstances and whether those circumstances are such that the employer should have inferred that the employee was not authorized to work in the United States. It is essential, however, that an employer balance the actions it takes when confronted with possible constructive notice against the prohibitions against national origin discrimination and citizenship discrimination that are embodied in other laws.

The Alabama Immigration Law adds penalties to those currently in place under the federal system: upon a first violation, a court must order, among other things, that the employer's business license be suspended for up to ten days and the employer is placed on a three-year probationary period with accompanying reporting requirements to the local District Attorney's office. A second violation results in the permanent revocation of all business licenses/permits at the location where the illegal worker performed work. A third violation results in the permanent revocation of licenses/permits for all of the employer's Alabama locations. The Alabama Immigration Law includes provisions by which contractors can insulate themselves from liability for their subcontractors' failure to comply with the Alabama Immigration Law through the use of an affidavit of compliance. A sample affidavit is available on the HBAA website, www.HBAA.org.

The law expressly prohibits state agencies from looking the other way for favored businesses as doing so is deemed to be an independent violation of the statute by the government agency. Section 15 (k), the "tattletale" provision, permits a private citizen to make a formal complaint directly to the Alabama Attorney General that an employer is knowingly employing unauthorized workers or failing to use E-Verify. The Attorney General must respond to any signed petition within 60 days of receiving the petition. There is, of course, a business incentive to report a competitor whose pricing might be more competitive based on lower labor expenses which may well encourage a culture of intra-industry enforcement to ensure a "level" playing field.

Mandatory E-Verify

The most significant departure from existing federal requirements that will require action by all Alabama employers is the requirement that Alabama employers participate in E-Verify, the DHS electronic employment eligibility verification process. Outside of the context of certain federal contracts, E-Verify is completely voluntary for Alabama employers under federal law. Further, unlike the immigration enforcement laws in other states, there is no exception for smaller employers and employers with only one employee must use E-Verify. There are two effective dates for the E-Verify mandate. State contractors, defined in the law as any employer who receives "any contract, grant, or incentive" from the state or "any state-funded entity" must participate in DHS's electronic employment authorization (E-Verify) program beginning January 1, 2012 prior to receiving any contract grant or incentive. It is unclear whether these public contractors must enroll as of January 1st or prior to entering a new agreement with the public entity. Notwithstanding that the effective date for state contractors is somewhat unclear, effective April 1, 2012, the E-Verify mandate is extended to all Alabama employers. The definition of "state funded entity" makes any entity that receives state monies a state funded entity regardless of the amount of the funding.

Small employers are not left completely on their own as the law mandated that the Alabama DHS create and maintain an "employer agent service" for all Alabama employers with 25 or fewer employees to use the E-Verify program. The

Alabama DHS has established that employer agent service and in providing information assistance to all Alabama employers through a website http://immigration.alabama.gov and hot-line (1.855.VERIFY6).

The use of E-Verify does have certain advantages including that, similar to federal law, an employer's good faith compliance with the E-Verify program affords the employer a defense that it did not knowingly hire or employ an illegal. Although not specified in the Alabama Immigration Law, the E-Verify requirement applies to new employees only, not to persons employed as of the effective date of the requirement.

Insulating Liability Related to the Employees of a Subcontractor

There has long been uncertainty surrounding the potential liability of a primary contractor's, including a general contractor for construction projects, for its subcontractors' employment of undocumented aliens. The new law limits the primary contractors' exposure under these circumstances by providing that a state contractor shall not be liable for its subcontractors' employment of undocumented aliens when the contractor receives a signed, notarized affidavit from the direct subcontractor that it has complied with the Alabama Immigration law in good faith unless the primary contractor knows otherwise.

Although the provision is set forth only in the public contracting entity section, it makes sense for all primary contractors to include the affidavit as part of their subcontractor agreements. That said, we have seen a number of form affidavits circulating that go well beyond the requirements of the Alabama Immigration Law and, in some cases, request that an employer affirm under oath that he or she has engaged in activity that would violate federal law (e.g., using E-Verify on current employees). If an employer has questions about the contents of an affidavit it is requested to sign, it should contact counsel. There is no requirement to update or renew the affidavit either on a periodic basis or with each successive subcontract.

The Fund expresses its appreciation to Noah for his service to the Fund and for his military service to the United States of America.


