If you are a QCI (Qualified Credentialed Inspector), you are required by ADEM to take a continuing education course each year in order to maintain your certified status. The HBAA offers two ways to obtain your continuing Ed credit--you choose what works best for you:

Take the course at your own pace in the comfort of your home or office.
